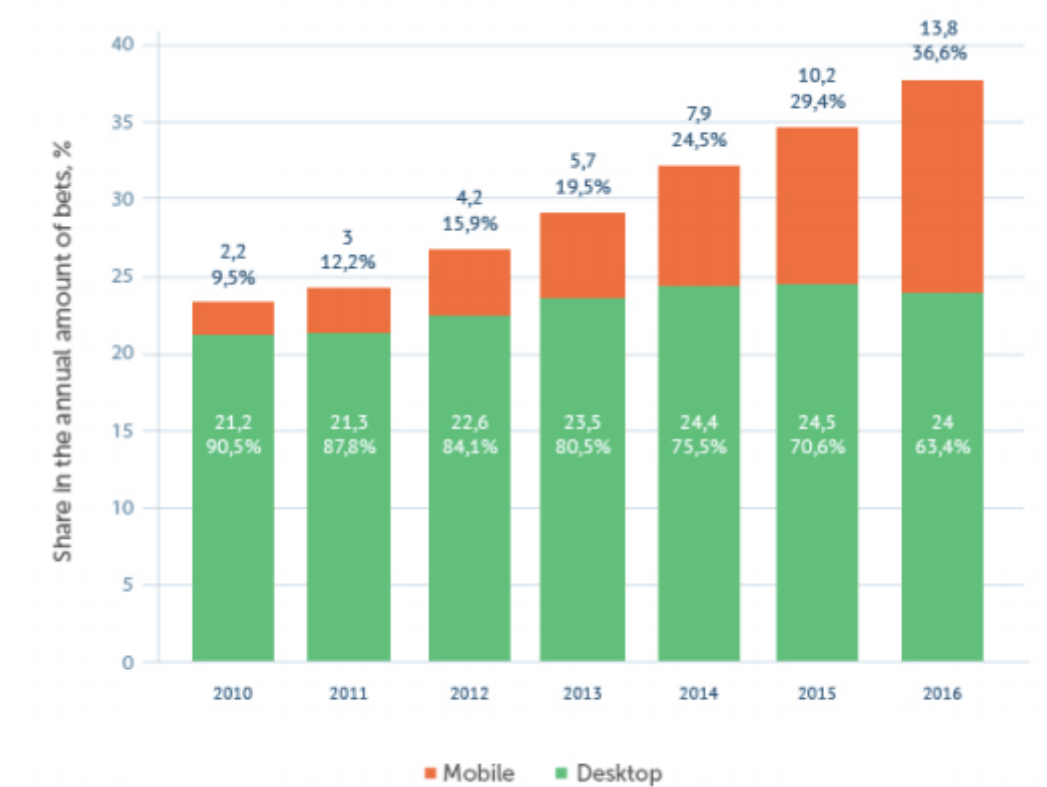

Market problems faced by operators

Then operators have been victims of carding and payments from stolen plastic cards. In a survey conducted by CasEXE, it was shown that around 33% of the operators faced this problem. The operator becomes practically powerless and helpless against this type of fraud.

Solution:

By making payments through TIDBIT payment wallet is 100% secure as all the transactions are accompanied over Blockchain platform. TIDBIT tokens are free from any fraud and are safely kept in the wallet and are transacted from there.

Problem #2 Not giving instant payouts

TECHNOLOGIES

Blockchain

A Blockchain is an **Open Ledger** which means everyone can see the transactions and verify the valid and invalid transactions. Instead of making the transaction private, the complete process is visible to all. The Blockchain is stored over a network of computers globally. The cryptographic functions and hash algorithms are well implemented to justify the ownership of funds. In case any person tries to transfer an invalid amount or hacker tries to hack the system, the nodes immediately deny the transaction and mark it invalid.

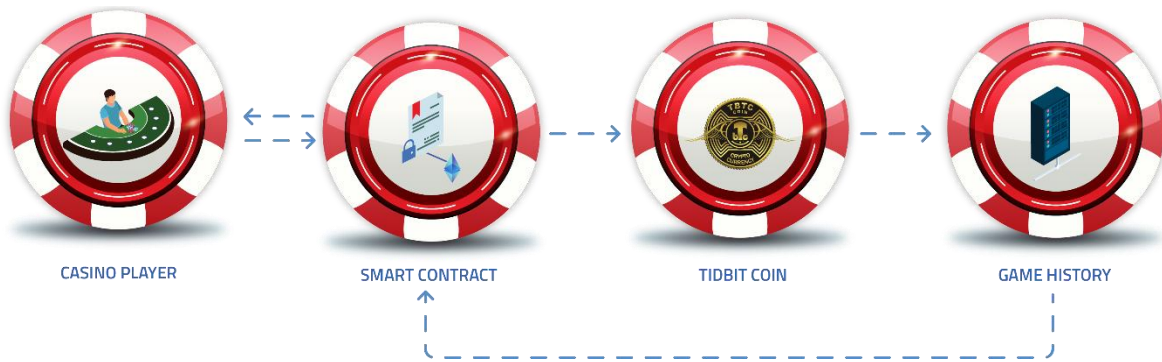
From the inception of the currency system, there was always a need of centralized authority for maintaining the transactions. This has some serious implications. The centralized system is indeed a single point of failure. They can impose their own transaction charges, can reverse a transaction or in case of any technical failure, the information can be lost.

All the nodes of the network can have their copy of the open ledger, so there isn't a need of the central authority. The distributed nature of the Blockchain makes every transaction authentic and completely secure. Thus, making it virtually impossible to hack or corrupt a transaction.

So, A Blockchain is a decentralized open ledger which helps to make the transactions verifiable, counterfeit resistant, and not subject to the risk of institutional processing.

The TIDBIT platform

The TIDBIT platform is designed to resolve all the irregularities prevailing in the gambling industries related to trust, personal data protection and international market entry. The operational activates are visible to players and operators through an open ledger having a mathematical proof of authenticity.

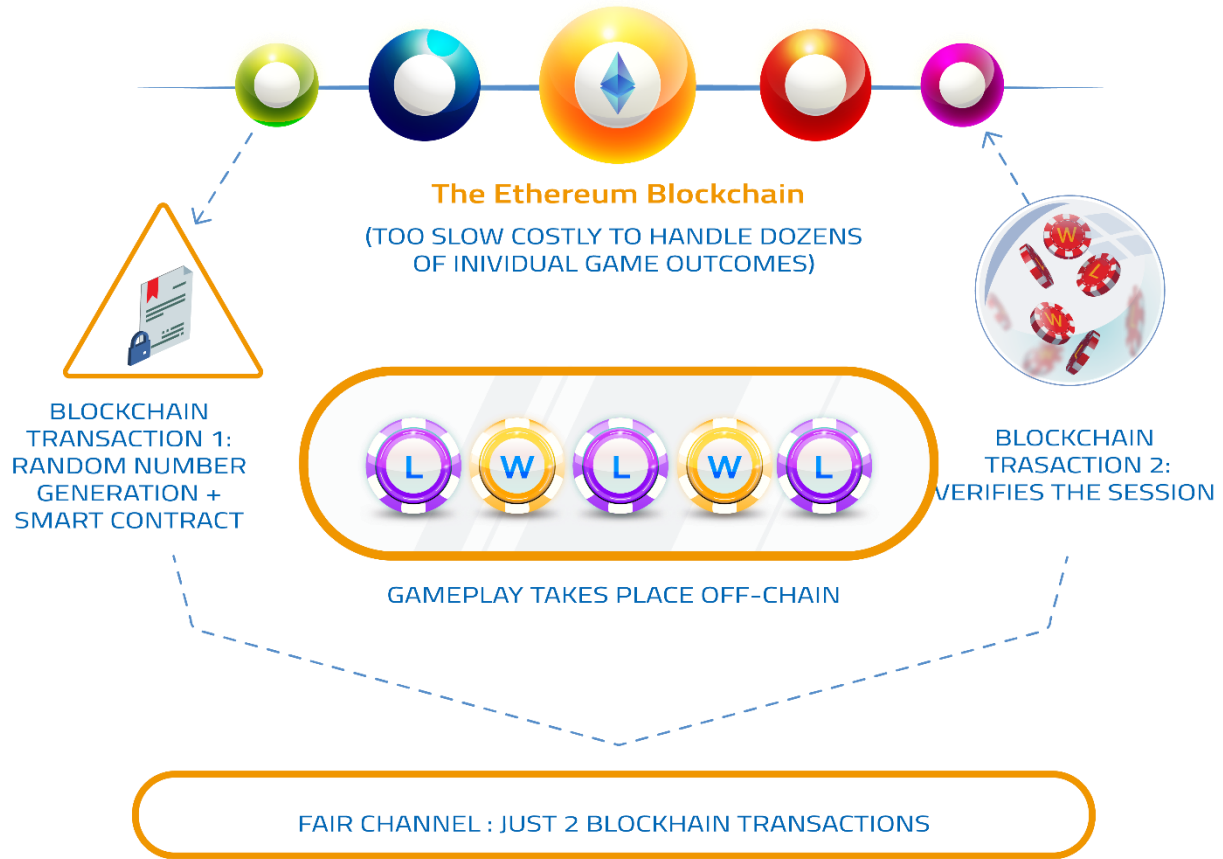
TIDBIT Channel

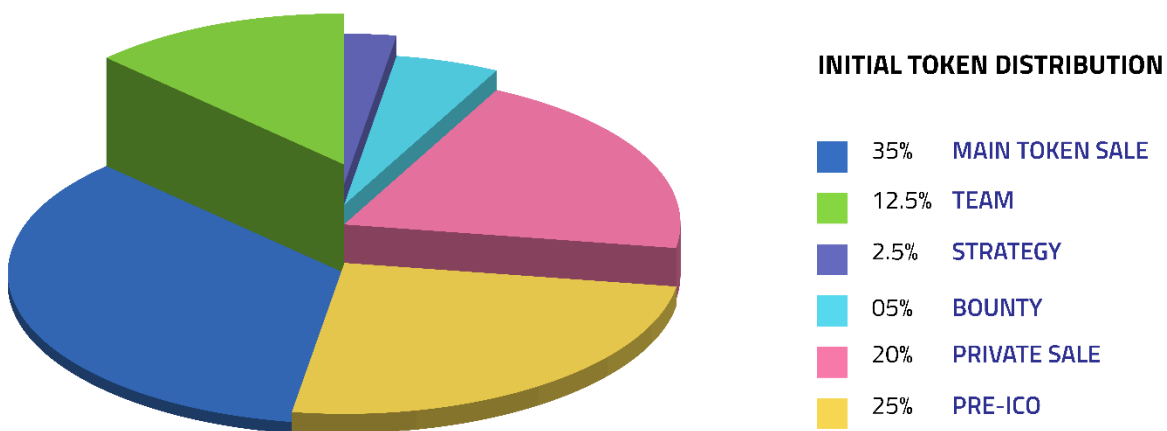
