

# 2 Introduction - FireAnts are little helpers!

The invention of the Bitcoin protocol has opened the door to new forms of financial interactions. One such form is the adaption of blockchain technologies for the use as a social currency. FireAnts which is a form of money created by the FireAnts association to serve the economic and social interests of people. FireAnts shall keep people active by combining blockchain technologies with humanitary and socio-economic challenges. This project strives to support souvereignty to individuals by providing an automomous financial data management and government system that is based on mathematics instead of trust.

Vulnerabilities are, in most cases, amenable to technological mitigations that must be adaptable to both community values and changing conditions, emphasizing the need for careful design. The FireAnts association and its developers are taking care of the state of the art design of the FireAnts blockchain. It is about creating a sense of community and by that a strong affiliation between customers, consumers and users of FireAnts. FireAnts increase engagement with consumers and interaction with customers, and by that adding to the customer conversation around the FireAnts, it grants access to information and knowledge, which is being shared within the FireAnts community.

FireAnts is also a platform for developers to create applications for the preservation of endangered cultures. Languages, cultures, and traditions can be preserved on the FireAnts blockchain. With the help of FireAnts, legacies can be recorded for eternity. In addition, archaeological finds or specific items could be tagged, digitized and monetized.

With no repository or single administrator, and since all the code used for its own functionally is open source, FireAnts is considered a decentralized system. The FireAnts association donates its FireAnts coins and tokens to philanthropic projects that aim to increase fairness and justice in human society. Among other things, the FireAnts associations focus is on the sovereignty of minorities and oppressed cultures that are dependent on centralized and inflationary systems.

FireAnts started as ERC-20 token on the Ethereum blockchain and developed their own native FireAnts blockchain based on the Scrypt (Litecoin) algorithm. The ERC-20 token can be burnt and claimed as BEP-20 token on the Binance Smart Chain.

## 3 The FireAnts Association

The FireAnts association is about to be formed by the FireAnts development team in the beginning of 2022. The headquater of the FireAnts association will be located in Bale, northwestern Switzerland. Next to the United States and Germany, the desicion was made to locate the FireAnts association in Switzerland, because it offers one of the worlds best statutory regulated environments for cryptocurrencies and digital assets. The focus of the FireAnts association is on souvereignty of people, philantropic and humanitory projects such as bank the unbanked and the offering of a decentralized finance, data management and voting system.

The FireAnts association spreads awareness of how to behave securely in a more and more digitized world. Philantropy and cybersecurity are some of the most important keypoints. The FireAnts association serves as donation aggreagtor, whereby the ANTS coin and rANTS token will be donated to the various scientific projects of the FireAnts directors board of advisors, allowing them to generate funds for their projects, to bring then faster to completion and success. In comparison to other associations, the Fireants association only charges little membership fee and everyone is able to join the FireAnts association by contribution of work. Ideally this is coverd humanitarian-, social-, or sustainability work, cybersecurity projects or blockchain programming. The FireAnts association cares about marketing and merchandise, to bring FireAnts as a decentralized status symbol into public awareness. The FireAnts association has premined 52,500,000 ANTS coins, which are 25% of the FireAnts ANTS coin total supply. A fixed amount of ANTS coin and rANTS BEP-20 token will be regularly donated to the board of advisors.

A large amount of the premined ANTS coin is reserved for donations and for donation aggregation by staking, the staking rewards will be regularly donated to the directors board of advisors.

Developers and members of the FireAnts association will maintaim the network until this becomes fully decentralized. In a subsequent process, the FireAnts blockchain will fully move to a proof of stake consensus that allows the owners of the ANTS coin to create masternodes which enable to earn ANTS coin as validator on the FireAnts network. The masternode concept allows the implementation of a data layer to the network, enabling the creation of smart contracts, voting systems and non-fungible tokens (NFT's). While the FireAnts blockchain is in its mining and distribution epoch, the FireAnts association is actively mining ANTS coin and adds these coins to the donation aggregator wallet, permanently increase the amount of ANTS coins available for donations.

# 4 The Directors Board of Advisors

The directors board of advisors are projects and persons of public interest that aim to improve social souvereignty and help to bring more fairness and equity to the future of humanity. Every scientific project is able to apply to the directors board of advisors, and will be supported by the FireAnts association. The first advisors of the FireAnts association are Dr. Andrea C McAleenan, Ph. D., Dr. Nicole Cochran, Ed. D and Dr. Peng Wen, Ph. D.

#### 4.1 Dr. Andrea C McAleenan, Ph. D.

Dr. McAleenan's career spans senior leadership positions in public and private higher education, K-12 and the not-for-profit sector. Her work encompasses academic and student affairs administration, graduate and undergraduate level teaching and advancement (friend and fund raising, major gift work, special events, marketing and communications, alumni relations).

Bridge building, networking and partnership development are signature threads throughout her career. Dr. McAleenan began her career in public school counseling serving at-risk student populations in Michigan and Hawaii. Dr. McAleenan moved to the University of Hawaii where she designed system-wide admissions and articulation strategies for eight campuses. Her public higher education work continued at California State University, Northridge where she designed a university wide orientation and retention model.

Transitioning to private higher education, she co-founded a Masters Degree program in College Student Development serving as professor and department chair, prior to becoming the Dean of Instruction at Azusa Pacific University where she was responsible for accreditation, faculty development, enrollment management, and the Offices of the Registrar, Multiethnic Students, Learning Skills Center, Center for Personal and Career Development and Orientation.

As part of a four-year Federal agency partnership, Dr. McAleenan moved to Communities in Schools based in Washington D.C. to establish integrated approaches for student retention in large urban school districts. Dr. McAleenan served as Director of Communications and Congressional

Liaison prior to establishing and directing the Western Region's Center for Partnership Development and Training in Los Angeles.McAleenan joined the administration at the University of California, Los Angeles (UCLA) serving as Assistant Dean for the Executive and part-time MBA programs at the Anderson Graduate School of Management.

Identifying partners and coordinating international field study projects enabled her to work with many multinational companies including, NOKIA, SONY, BHP (Australia), AVL (Austria), SGS-THOMSON (France), New Zealand Enterprises, and DISNEY EUROPE. Dr. McAleenan founded UCLA's Global Partners Forum and became Associate Dean for International Relations, collaborating with business and government entities in 26 countries.

Dr. McAleenan was asked to join the Peter F. Drucker Graduate School of Management at Claremont Graduate University as Executive Director and Chief Operating Officer and later was appointed Dean of Executive and Extended Learning. Following that she served as Vice President for Advancement and Chief Development Officer for InterVarsity (Madison, WI) where she designed comprehensive advancement, fund development, alumni and communication strategies for national and international constituencies. Dr. McAleenan returned to California as the Special Advisor to the President of Azusa Pacific University.

She focused on increasing the University's visibility and impact on national and international platforms including a creating a Global Think Tank for government, business and academia leaders from 45 countries at Lausanne's international gathering in Cape Town, South Africa.

Dr. McAleenan moved to the Central Valley of California where she was on the faculty of the School of Business at Fresno Pacific University teaching Global Management and Leadership in the MBA program. She also served as Director of External Relations and Partnership Development.

#### 4.3 Dr. Peng Wen, Ph. D.

Raised in rural Taiwan in a non-Christian family, Dr. Peng Wen Ph. D., who retired in July 2019 as professor of business administration and economics, and director of the MBA program, came to the U.S. in 1985 to earn his MBA at the University of Oklahoma City and PhD of Economics at the University of Florida. When he just arrived the US, he joined a Bible study to help his English proficiency and learned more than he bargained for. "To practice English conversation, you have to ask questions, to ask questions you have to read ahead," he says.

Wen made his confession of faith four months later. An ad in the Chronicle of Higher Education brought Fresno Pacific to Dr. Wen's attention while he was finishing his Ph. D. at the University of Florida at Gainesville. He came in 1990, looking for a place to share his faith through teaching economics and finance. "When this job was offered to me I said, 'Perfect,'" he says. There have been offers since he was tempted by one from financial giant Goldman Sachs. "I prayed about it and realized that's not about mission, that's about the material," he says.

Mission drives Dr. Peng Wen Ph. D. "God calls me to start a church wherever I am," he says, including one in Gainesville and the Chinese Fellowship at Bethany Church, Fresno.

In 2019 Dr. Peng Wen Ph. D. started to go to China to train church leaders. He will continue at Bethany church Chinese Fellowship until he trains a successor, then plant more churches in mainland China and Taiwan. As he told Christian Leader magazine: "When I confessed my sins to Jesus, I said: "I don't desire just to know you, I desire to make you known."

The FireAnts ecosystem consists of the native FireAnts coin [ANTS], wrappedFireAnts BEP-20 token [wANTS] that relect the FireAnts coin on the Binance Smart Chain, the redFireAnts BEP-20 token [rANTS] and the FireAnts ERC-20 token [ANTS]. The ratio between rANTS BEP-20 token to ANTS coin is 100,000:1, meaning that one ANTS coin is worth 100,000 rANTS BEP-20 tokens. Users are able to swap between ANTS coin and rANTS BEP-20 tokens. In addition, the ANTS coin can be 1:1 wrapped to wANTS BEP-20 to the Binance Smart Chain, allowing access to DeFi applications, such as yield farming, liquidity mining and many other applications provided by the Binance Smart Chain. The wrapping service for the ANTS coin is provided by the Team of Monetaryunit.

Due to high gas fees for transactions on the Ethereum blockchain, low volume transactions are not suitable for investors when using ERC20-token, here the Binance Smart Chain offers a cost saving solution to participate in the DeFi space. To allow the ANTS ERC-20 token to move to Binance Smart Chain users can claim rANTS BEP-20 token by burning ANTS ERC-20 token.

One year after the creation of ANTS ERC-20 token on the Ethereum blockchain, the FireAnts Team has developed a own blockchain system using the ANTS coin as native curreny. To enable interaction between ANTS coin and rANTS BEP-20 token on the Binance Smart Chain, the ANTS coin can be wrapped 1:1 to the Binance Smart Chain.


~ 210,000,000 ANTS coin will ever be created and this cannot be altered due to the code programmed into the blockchain.

25% of the total ANTS supply has been premined. These premined coins are used by the FireAnts association for donation aggregation and blockchain development.

16.5% of the total supply of ANTS coin can be mined using the Scrypt (Litecoin) algorithm, and the other 58.5% ANTS coin will be minted by staking in wallets and masternodes. The block time for the generation of each block is approx. 3 min.

In 2025, the proof of work phase will end at block 691200 and the FireAnts bolckchain will move completely to Proof of Stake consensus. Masternodes will be implemented when the change from the proof of work to proof of stake happens. This way it can be ensured that the power consumption of the FireAnts network can be kept at an environmental friendly level.

# 7.1 FireAnts premined ANTS coin distribution



30% of the premined ANTS coin supply is reserved for donations and 25% of the premined ANTS coin supply is reserved for investors.

25% of the premined ANTS coins are used as liquidity to generate staking rewards in the donation aggregator wallet, the staking rewards will be regularly donated to the directors board of advisors projects.

10% of the premined ANTS coins will be used to secure the FireAnts network using state of the art technologies.

5% of the premined ANTS coins is used for marketing, these ANTS coin will be distributed by tip-bots for airdrops, faucets and will be given away on charity events and 5% of the premined ANTS coins will be used for the FireAnts team development.

# 8 Blockreward cycles of FireAnts coin

Unlike bitcoin, the blockreward reduction cycles (known as halving) on the FireAnts blockchain happens every 24 month. This reduction follows its unique pattern and enables a steady state condition at a supply of ~210,000,000 ANTS coin. This ammount will never be exceeded! Starting with a block reward of 100 ANTS coin per block, whereby the blocks are randomly with 50 / 50% probability are distributed between miners and stakers.

The first blockreward reduction will take place at block 345'600, then the supply of the blockreward will be to 40 ANTS coins.

The second blockreward reduction at block 691,200 will reduce the blockreward to 30 ANTS coin per block.

In this phase the FireAnts blockchain will undergo a transition to a new epoch, the blockchain will completely leave the proof ow work consensus and move to full proof of stake with masternodes consensus. The FireAnts blockchain then allows the creation of masternodes for ANTS coin holders, and a data layer is integrated that allows the creation of smart contracts and non fungible tokens (NFT's).

The 3<sup>rd</sup> reduction will generate 20 ANTS coin per block.

The 4<sup>th</sup> reduction will generate 10 ANTS coin per block.


The 5<sup>th</sup> reduction will generate 5 ANTS coin per block.

The 6<sup>th</sup> reduction will generate 2 ANTS coin per block.

The 7<sup>th</sup> reduction will generate 1 ANTS coin per block.

The 8<sup>th</sup> and last blockreward reduction will generate 0.1 ANTS coin per block. From this point on, the blockreward will remain permanently at 0.1 ANTS coin per block, this will be no longer reduced. Due to the transaction fees burnt by transactions, the supply of the FireAnts coin will reach an equilibrium of ~210,000,000 ANTS coin in the year 2057.

The rANTS BEP-20 token is used as gateway into decentralized finance of the Binance Smart Chain. The smartcontract can easily be integrated into applications running on BSC. The rANTS BEP-20 token can be safely stored in multicoin wallets accepting BEP-20 tokens, such as Metamask, Trustwallet or Coinomi.

To keep transaction costs at a minimum, the FireAnts team has moved the initial ERC-20 smartcontract to the Binance Smart Chain. Users can burn their ANTS ERC-20 token on the Ethereum blockchain, and are able to claim the same amount of redFireAnts [rANTS] token on Binance Smart Chain.

#### 10.1 redFireAnts token distribution



30% of the rANTS token supply is reserved for donations to the directors board of advisors to support their projects as well as donations in case of devastating events like natural disasters or similar.

20% of the rANTS token supply is reserved for investors.

10% of the rANTS token supply is used to secure the FireAnts network.

10% of the rANTS token supply is used for marketing, the redFireAnts token will be distributed by tip-bots for airdrops, faucets and will be given away on charity events.

10% of the rANTS token supply is reserved for FireAnts blockchain development.

5% of the rANTS token supply will be used for website developmentand 5% for servers and hardware for the support of the FireAnts team.
